### Legislative April report Continued

HB2053 AUTONOMOUS VEH REQUIREMENTS (KIFOWIT S) Amends the Illinois Vehicle Code. Defines "autonomous vehicle" as a motor vehicle that possesses the capability (enabled or not) for automated functions to control movement of the vehicle along 2 axes of direction simultaneously. Provides that, before selling or continuing to operate a new or used autonomous vehicle in this State and before updating the software or hardware of any automated driving system on such a vehicle, a manufacturer shall submit to the Department of Transportation documentation regarding the level of driving automation, along with a filing fee in an amount to be determined by the Department. Provides that the Department shall assemble an Automated Driving Systems Review Committee to evaluate submitted documentation and make determinations concerning the level of automated driving capabilities and the suitability of the vehicle for operation on public roads. Provides that an autonomous vehicle classified as having Level 2 Driving Automation may be sold to consumers and registered for use. Provides that the owner of the automated vehicle shall file an annual report with the Department of Transportation stating the number of miles driven per year, the estimated number of miles driven using equipped automated driving systems, and any collisions that occurred involving the vehicle. Prohibits the sale or operation of autonomous vehicles classified as having Level 3, 4, or 5 Driving Automation. Provides that a resident may file a request for the Automated Driving Systems Review Committee to review an existing vehicle sold or registered in this State, and that the Secretary of State shall receive and investigate complaints of a dealer selling a vehicle prohibited for sale under the new provisions. Provides that a person who operates a prohibited vehicle is guilty of a Class A misdemeanor and that such a vehicle is subject to impoundment. Provides penalties for the unauthorized sale or modification of an autonomous vehicle.

Comments: This bill eliminates the duplicate motorcycle testing requirement for 16-17 yrs olds. This bill still requires 16-17 yr olds to attend and successfully complete a MSF Basic Rider Course which includes the standard SOS riding test as part of its curriculum and is a higher standard than what is placed on potential riders 18+ in age. It eliminates the requirement to test a 2nd time at a SOS facility.

## *Battle Lines Being Drawn*

*In August 2022 California Governor Gavin Newsom announced, and the California Air Resources Board (CARB) approved, an executive order requiring sales of all new passenger vehicles be zero-emission by 2035. While the California directive doesn't include motorcycles yet, motorcyclist advocates in the Golden State have warned that motorcycles will be an obvious next target.*

*Unsurprisingly, other states quickly followed suit and enacted similar policies. Massachusetts, Oregon, Washington, New York, New Jersey, and Maryland have all sought to put similar restrictions in place. In total 17 states have laws that bind their emissions regulations to those of California.*

*However, leaders in many states, including those that are obliged to follow California's lead, are pushing back. In Colorado, the Energy Office said, "While the governor shares the goal of rapidly moving towards electric vehicles, he is skeptical about requiring 100% of cars sold to be electric by a certain date as technology is rapidly changing."*

*Virginia governor Glenn Youngkin was even more forceful, "I am already at work to prevent this ridiculous edict from being forced on Virginians. California's out of touch laws have no place in our Commonwealth."*

*This month the New Hampshire House of Representatives voted down a bill that would have forced New Hampshire to match California's emissions goals.*

*Congressional Republicans are also joining the fight against the California policies. Last week H.R. 1435 was introduced, titled the "Preserving Choice in Vehicle Purchases Act." H.R. 1435 would amend the Clean Air Act to prevent the elimination of the sale of internal combustion engines, effectively overruling California's move. Within just a week, 66 cosponsors from 26 different states joined in support.*

*The movement isn't contained to the United States. Last month, the European Parliament formally approved a law to effectively ban the sale of new gas- and diesel-powered vehicles in the European Union starting in 2035. But Europe, too, is seeing pushback. Farmers in the Netherlands have taken to the streets in protest of emissions regulations. Member nations of the EU are also expressing a desire to make changes to the newly enacted policy. Germany, the Czech Republic, Hungary, Italy, Poland, Romania, and Slovakia are discussing what changes they'd like to see to the European Union's 2035 plan.*

*This issue is not new to the MRF. Our 2023 legislative agenda includes this priority: "Work against any efforts by the California Air Resources Board (CARB) that endanger the future of motorcycling."*

*We are ready for this fight and will work with partners across the country to defend the future of motorcycling and the lifestyle we cherish!*

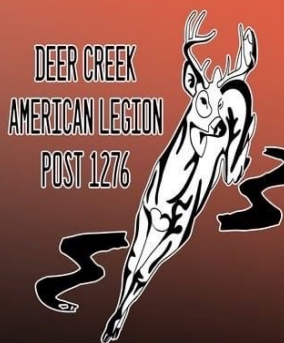

## Safety

Riding a motorcycle is one of the most freeing sensations you can ever experience in life. Your safety is sacred and therefore you need to take all necessary precautions and steps to avoid getting into an accident in the first place or suffering because of the mistakes of someone else on the road. Wearing motorcycle safety gear at all times can keep you safe and protect your body from physical harm if you unfortunately happen to lose balance and have an accident. In addition to staying protected by dressing for the slide not the ride. I will be highlighting tips that we should know but maybe need to be reminded.

**Don't tie shoelaces in loops!**

Have you ever noticed why motorcycle riding boots do not have laces in them? It is because the laces can get in the way of shifting gears or applying the brakes, and they can get tangled in the brake lever and lead to an accident. Even if you have to wear a pair of everyday boots with laces, make sure the laces are not tied in big, large loops which can catch in the foot pegs or on the gear lever. It is also a good idea to tie the loops behind your heel and keep it tucked inside the boot for added protection.

**Don't watch the speedometer, watch the road!**

When you're riding a motorcycle, your focus should always be on the road and not anything else! Many people make the mistake of watching the speedometer when they are going at high speeds just for the sake of personal gratification. It is one of the most common mistakes that you need to avoid because when you are at high speeds, you don't get a lot of time to rectify mistakes, if any at all! Even in the condition that you need to check your speed to maintain speed limits on the road, do it quickly and look back on the road as soon as possible. Kande Simpson

## ***NHTSA Responds to Questions from Congress***

*Just before the end of 2022, Rep. Tim Walberg of Michigan and 26 of his colleagues in Congress sent a letter to the National Highway Traffic Safety Administration (NHTSA) regarding recent crashes that involve motorcycles and cars believed to be in self-driving mode.*

*The response from government regulators has some key takeaways:*

*“NHTSA is actively working to educate consumers and the media that ADAS technologies are not self-driving technologies, and that drivers must always remain engaged in the driving task.”*

*“Crashes involving motorcycles account for less than 2 percent of all reported crashes involving vehicles with either ADS or Level 2 ADAS technologies.”*

*“NHTSA is conducting research on how vehicles equipped with crash avoidance technologies react to motorcycles, bicyclists and other vulnerable road users in various scenarios.”*

*The Motorcycle Riders Foundation is committed to aggressively working with lawmakers to address obvious safety gaps in the deployment of this new technology. While we appreciate that NHTSA is conducting research on this topic, on this topic, motorcyclists are not “vulnerable road users”, motorcyclists are simply road users.*

*Additionally, it’s unacceptable that consumers falsely believe ADAS technology, deployed on our roads, allows them to sit back and relax while in the driver’s seat. The safety of the nearly 10 million bikers on our nation’s roadways requires that all roadway users act in a responsible*

## ***Major Car Maker Having Second Thoughts?***

*A letter released to the public on Thursday, from the **Ford Motor Company** to the National Highway Traffic Safety Administration (NHTSA) regarding automated driving systems is eye opener. While not giving up on “self-driving cars” Ford appears to be dialing back their testing and investment.*

*In the letter, Ford formally withdraws a petition seeking U.S. regulatory approval to deploy up to 2,500 self-driving vehicles annually without required human controls like steering wheels. Ford states, “We believe the road to fully autonomous vehicles, at scale, with a profitable business model, will be a long one.”*

*In December, the Motorcycle Riders Foundation (MRF) worked with bipartisan lawmakers in Washington, D.C. to get answers from NHTSA about this new technology. The deployment of vehicles like the type mentioned in the Ford letter, are a major concern of motorcyclists. The MRF remains troubled by the rush to allow testing of these vehicles on public roads.*

*While the decision by Ford appears to be based on the economic reality surrounding this new technology, the MRF applauds any decision that pauses the deployment of this unproven technology on our nation’s roads.*
